Private Functions Terms & Conditions

To ensure a safe and memorable time at Bon Game Reserve, kindly adhere to the following rules and regulations. Please read them carefully before booking. Understand that by booking with us, you agree to be bound by these terms and conditions.

We have the right to revise and amend these terms and conditions from time to time to reflect changes in technology, changes in payment methods, changes in relevant laws and regulatory requirements and changes in our system's capabilities.

PAYMENT

- Please note that you must be 18 years or older to make a private function reservation.
- Prices are liable to change at any time. Changes will not affect bookings in respect of which we have already sent you a Booking Confirmation, except in cases of obvious error.
- The rates are calculated in ZAR (South African Rand).
- A non-refundable deposit of 50% to secure your provisional booking, is required.
- We will hold the booking on a provisional basis for seven (7) days, until a signed copy of this agreement is received.
- Provisional bookings will be released without notification, should you fail to make payment of the deposit and provide Bon Game Private Reserve with the necessary documentation within the seven (7) day period.
- The total outstanding amount must be paid prior to or upon arrival; after making a booking you will receive an e-mail confirmation. Please note, your booking is not confirmed until full payment has been received.
- For exclusive use bookings, an additional breakage deposit fee of R5000 will be added to the quote, and for smaller private function the breakage deposit fee is R500. This includes, but not limited to, glassware, cutlery and crockery. The deposit will be refunded within two (2) weeks of the event date.
- All outstanding payments accrued during your function must be settled before departure.

CANCELLATION POLICY

- Between 0-7 days prior to arrival, forfeit 100% of the deposit. Between 8-15 days of arrival forfeit 50%. Between 16-30 days of arrival forfeit 25%.
- No verbal cancellations will be accepted. Only written cancellations will be accepted. Ensure that you receive an acknowledgement of your cancellation from reservations.
- All refunds are subject to a 15% admin fee.

SPECIAL OFFERS

- We reserve the right to run special promotional offers on events. Special Offers may include, but are not limited to, price promotions.
- In the event of a Special Offer, additional terms and conditions may apply which will be made available at the time of booking.

SPECIAL REQUESTS

TIMINGS

- The bar & restaurant hours are from 08:00-17:00.
- It may remain open when pre-arranged upon booking.
- The venue is only available on the day the venue has been reserved. Should you, or your representative, require prior entry for setup, or post entry for breakdown, please communicate with reservations.
- Setting up the venue remains the paying guest's responsibility.
- All our venues close at 00:30 latest. Functions must end by time agreed upon. Should functions not end by time prior agreed on, Management reserves the right to retain the full breakage deposit.
- Please consider the other guests by keeping the noise levels as low as possible.
- No music from motor vehicles or private sound systems/equipment is permitted, that includes the church bells.
- No ATV's are allowed.

THE PREMISES

- All pre-booked outdoor activities are determined by weather conditions and is always at the discretion of Bon Game Reserve Management. Any trip may be shortened, or cancelled at short notice, due to conditions, which may pose a risk to guests.
- There may be other private group bookings at Bon Game Private Reserve unless you booked exclusive use. For more information in this regard, please contact reception.
- We charge a cork fee of R150 per bottle when entering the premises with outside food & drinks.
- Report any faults immediately.
- Please don't remove any glassware or crockery from the restaurant.
- We have an on and off liquor license so you can enjoy drinks in our restaurant or for take-away.
- The premises shall always be under the control of the Bon Game Reserve which reserves the right to impose any terms and conditions in addition to those contained herein, as it may deem necessary, in order to ensure that the rights of other visitors to Bon Game Reserve, the neighbors and others are respected.
- The Venue Hire is restricted to Bon Game Reserve only.
- Guest arrangements for music should be discussed with and approved by Bon Game Reserve. Any request by Bon Game Reserve Management for music volume levels to be reduced must be complied with. If in the opinion of Bon Game Reserve Management, the pre agreed noise levels are exceeded, the full breakage deposit of R5000 will be retained.
- The paying guest and Bon Game Reserve Management should meet one week prior to the function to discuss procedures for the event as well as special requests. All role players should be present to be involved in the process.
- The paying guest must ensure that the premises is returned to Bon Game Reserve in the same good order and condition in which it was found.
- Management will not be held responsible for any reason whatsoever for the non-functioning of any equipment brought onto the premises by the function holder.
- The function holder will be responsible and liable for any damage or loss caused to Bon Game Reserve by any of the sub-contractors hired for the function.
- Bon Game Reserve and/or its staff will under no circumstances be liable for the loss, damage and/or theft of any of the subcontractor's equipment or loss or damage to any property of the guest attending the function.
- Maximum numbers will always be adhered to. Failure to adhere to maximum numbers will result in the function being cancelled.
- Final numbers must be confirmed 7 (seven) days before your function.
- All refuse must be removed by the paying guest immediately after the function.
- All equipment brought onto the premises by the paying guest or any of its contractors must be removed from the premises within 24 hours.

RIGHTS IN MATERIALS

- Bon Game Reserve must approve all publicity and advertising relating to the function.
- Bon Game Reserve may photograph or film the event for marketing purposes. By attending an event, you are giving us permission to use images in which you may be present. In addition, these images may be shared and stored on third-party platforms. Should you not wish to appear in any images, please notify Bon Game Reserve Management at the event.
- All copyright and other rights (including all intellectual property rights) in materials provided to you during or for the purposes of any of our Events (including, without limitation, course notes, slides, brochures, articles or case studies) are the property of Bon Game Reserve. You are entitled to use such materials for personal use only.

- You are not entitled to copy such materials (except as permitted by law) nor are you entitled to use or authorise others to use such materials for any commercial purposes.

INDEMNITY

- By agreeing to this Private Function Terms & Conditions, you also agree to the terms set out on the Registration Waiver/Indemnity form. All guests entering the premises must complete the said Indemnity prior to or upon arrival.

BREACH

- The terms and conditions of this agreement are all deemed to be material and should the function holder and/or its subcontractors be in breach of any of these terms and conditions, Bon Game Reserve will be entitled to: or cancel the function forthwith; or claim the full hire charges and retain the breakage deposit; or claim any damages it may have suffered because of the breach.
- The interest payable to Bon Game Reserve for any money outstanding will be calculated at the prime overdraft rate.

SEVERABILITY

If any particular provision and/or term of this Agreement is found to be defective or unenforceable or is cancelled for any reason (whether by any competent Court or otherwise) then the remaining provisions and/or terms shall continue to be of full force and effect. Each provision and/or term of this Agreement shall accordingly be construed as entirely separate and separately enforceable in the widest sense from the other provisions and/or terms hereof.

COUNTERPARTS

This Agreement may be entered into any number of counterparts and by the Parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.

WHOLE AGREEMENT

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof. No agreements guarantees or representations, whether verbal or in writing, have been concluded, issued or made, upon which any party is relying in concluding this Agreement, save to the extent set out herein.

NO VARIATION

No variation of, or addition to or agreed cancellation of this Agreement shall be of any force or effect unless it is reduced to writing and signed by or on behalf of all parties.

ALL SWIMMING FACILITIES

- No diving & no running. Edges are slippery when wet.
- No glasses on edges.
- No smoking.
- Only accepted swimwear is allowed.
- Own swimming towels must be provided.
- The Mineral bath between restaurant and bar is not included, but can be used at an extra fee.
- No swimming or fishing allowed in the dam.
- River activities are at own risk. Bon Game Reserve can't be held responsible for any loss of life or injury.

SPEED LIMIT

- The speed limit is 20 km/h.
- Please watch for children, roaming animals and tortoises.
- You are not allowed to drive "off-road" or on roads with a "no entry" sign.

PETS

- No pets (dogs, cats, or any other) may be brought onto Bon Game Reserve.
- Guide dogs for visually impaired guests are an exception, but only in consultation with management and if the owner has the necessary inoculations and permits as ordained by the state veterinary department.

WILDLIFE / FLORA & FAUNA

- The feeding or intentional disturbance of wildlife is a serious offence. By feeding any wildlife you are potentially signing their death warrant, as they may become dependent and often become aggressive and dangerous, and thus have to be exterminated.
- Remember, animals see litter as food!
- No plant, animal, wildlife or any natural or cultural items may be removed from Bon Game Reserve without permission.
- To cut, damage, destroy or be in possession of any plant or part thereof, including dry wood or firewood is a serious offence.
- Importing of any specimen of an alien or listed invasive species onto Bon Game Private Reserve is prohibited.
- Poaching, killing or injuring of animals is strictly prohibited.

SAFETY

- Please wait for the main reserve gate to close behind you once you passed through. We want to keep you and the wildlife safe.

- Adult supervision required at all times, no children allowed unsupervised.
- Please do not tamper or damage Play Area equipment.
- We have multiple bodies of water, drains, caves and natural holes around Bon Game Reserve. Please do not leave children unattended.
- For safety reasons some activities conducted at Bon Game Reserve have age or height restrictions.
- All firearms/dangerous weapons of any sort, any explosive, trap or poison must be declared upon entry, and firearms will then be kept in the reception safe.
- Please do not wander off on your own, there are nature walks available.
- Bon Game Reserve can't be held responsible for lost or stolen goods.
- This is a nature reserve, please be cautious of snakes and other wild animals.
- The use of drones inside (and over) our reserve is strictly prohibited.
- Fireworks are strictly prohibited.
- No hot ash in dustbins please.
- Starting or causing of any fire, whether it be intentional or unintentional other than in a fireplace or container purposely made available is strictly prohibited and will result in a summons being issued.
- Smoking; strictly no smoking in any of our buildings. Please make use of designated smoking areas and ashtrays.
- Bon Game Reserve has a strict "No-littering" policy.
- Property is under 24 hour surveillance and on-site security personnel in the evenings.

The undertakings, warranties, indemnities, and waivers as herein set out are furnished in favor of Bon Game Reserve, the owner, operators, directors, shareholders, principals, partners, employees, contractors, and agents of all the aforementioned (collectively and severally "the indemnitees").

All adult guests must ensure understanding and acceptance of the content of this document by signing the relevant sections.

I acknowledge the following information and agree to the terms and conditions as stipulated:

- I am entering a Reserve and am fully aware of the dangers and risks arising due to the presence of wild animals, reptiles, birds, and insects ("wildlife").
- I will be participating in activities in and around the Reserve which are inherently dangerous, including, but not limited to, the viewing and exposure of and to wildlife, from open and/or closed vehicles, bush walks, hovercraft trips and on foot, utilising the Restaurant and Bar area and I understand and accept the risks inherent to these activities and areas.
- Entry and traversing on the Reserve, participation in all and any activities, shall be at my own risk and of those accompanying me for whom I am responsible.
- The indemnitees, including their insurers, are not liable should I, or any of those accompanying me for whom I am responsible, in any way suffer any physical injury, illness or other harm or death, or should any personal property (including any vehicle and/or contents thereof) be lost, stolen or damaged.
- Management and staff do not accept responsibility for private possessions, or any personal injury of any kind sustained while being on the Reserve.

All the rules, provisions, or clauses outlined in Section E are fully relevant and enforceable within the context of Section F.

I acknowledge and accept the following terms & conditions, related to the Hovercraft activity:

- The number and placement of passengers on the Hovercraft is decided at the sole discretion of the pilot. Once placed, passengers should not move around.
- Children under 1.3m are not allowed on the Hovercraft. The decision in terms of a child's eligibility to participate, is at the sole discretion of the pilot, who will consider all risk factors.
- All children must be under the supervision of an adult Parent/Guardian.
- No loose objects allowed onto the Hovercraft. Loose objects can distract the pilot, fall in the water, or become a hazard for the fan. There is a risk of water damage to electronic items, as there is water spray.
- Hair should be tied and no loose clothing or accessories. Long hair, straps, or loose objects should they come in contact with the lift fan, can cause serious injury or death.

- No food or drinks are allowed on the Hovercraft. The pilot will not allow any person under the influence of any substance on board.
- The total time on the Hovercraft will be determined by weather conditions and is always at the discretion of the pilot.
- Any trip may be shortened, or cancelled at short notice, due to gusty conditions, which may pose a risk to passengers.
- Obstacles and water levels along the route may lead to the pilot adjusting, or shortening the route for safety reasons.
- Engine, or belt failures may occur and a recovery plan is in place in case of a breakdown that cannot be resolved by the pilot. Such incidents and/or the need for recovery, may add unplanned time to the Hovercraft outing.
